# 1. Admissions Policy

### Graduate School of Sustainable Systems Science

The Graduate School of Sustainable Systems Science seeks applicants with the following qualities:

- OThose who have acquired basic knowledge and skills in the departments of Production Systems Science, Health Care Systems Science, and Glocal Culture of the master's program of the university or equivalent higher education institutions, and who have completed practical training in the specialized fields of their respective departments.
- OApplicants should have high aspirations for the sustainability of the region and the world, and who have a strong interest and desire to work with the field to create ideas that can be applied beyond the framework of existing academia in order to realize a sustainable society. Those who have an interest in other fields and a willingness to discover issues related to the sustainability of humanity as a whole and the immediate sphere of life, and to show the way to solutions.
- OIn deepening their individual expertise, they must be able to communicate with domestic and international researchers with resonance and cooperation, face challenges with an ethical view that respects the dignity of life and humanity, and have a strong will to solve problems.

### Division of Production System Science

The objective of this major is to nurture graduates who can contribute to local industries by utilizing their advanced expertise in engineering and by realizing sustainable production processes in the field of manufacturing. We seek applicants with the following abilities and qualities:

- OFundamental knowledge of mechanical engineering and the various fields of mechanics within its framework.
- OA person who is willing to build DX and GX systems utilizing information engineering, electrical and electronic engineering to realize sustainable production processes.
- OA person who is not limited to his or her own specialty, but has the drive and energy to actively collaborate with experts in other fields to create pathways to solving issues for sustainability.
- OThose who are willing to actively engage with local industry and play a leadership role in the development of local industry.

### Division of Health Sciences

The objective of this major is to nurture individuals who can contribute to the creation of sustainable communities through the systematic establishment of community-based healthcare and the development of medical devices. We seek applicants with the following abilities and qualities:

- OApplicants must have a master's degree (Health Sciences) awarded by the University's Department of Health Care Systems Science, or have academic ability equivalent to such a degree.
- OAbility to create and execute new ideas, cooperate with others, and take initiative to systematically

build sustainable healthcare.

Obesire to contribute to people's health and well-being and have a clear vision of their future career path as an advanced healthcare professional, researcher, or educator.

### Division of Glocal Cultures

The objective of this major is to nurture individuals who can work to resolve international and regional issues, to propose visionary and comprehensive paths in order to achieve a sustainable society from a humanities and social science perspective. We seek applicants with the following abilities and qualities:

- Obtained a master's degree from an accredited institution of higher education and have knowledge of the fundamentals of a specialized field.
- OAbility to use creativity and historical understanding to deepen their expertise in language and culture studies, political economy, and tourism studies, and propose visionary and comprehensive paths that are not bound by the existing frameworks within academia.
- OHave the abilities and skills necessary to identify and resolve issues related to the sustainability of Minami-Kaga (the southern area of Ishikawa Prefecture), the Hokuriku region, and globally.
- OThose who are equipped with the abilities and skills necessary to identify and solve various sustainability issues in Minami-Kaga and Hokuriku and the international community, who are proud of their own culture, who have developed the ability to explore the cultural diversity of their local communities, and who wish to play a leadership role in solving local problems.

# 3. Application Qualifications

Applicants must meet one of the following criteria. In addition to the general eligibility requirements, there are also some specific requirements that individual applications must meet. Please refer to the relevant page of each division's admission procedures.

### Applicants should:

- ① have master's degree or a professional degree, or those who expect to obtain one by March 31, 2025.
- ② have received a master's degree or a degree equivalent to a professional degree from a foreign country, or expect to receive such a degree by March 31, 2025.
- 3 have been awarded a master's degree or a degree equivalent to a professional degree by March 31, 2025, after completing an educational institution in Japan that is recognized in the school education system of the foreign country as having a graduate school curriculum in the foreign country.
- 4 have received a master's degree or a degree equivalent to a professional degree by completing correspondence courses offered by foreign schools in Japan, and persons who expect to receive such a degree by March 31, 2025.
- (5) have completed a program at the United Nations University, which was established pursuant to a resolution adopted by the United Nations General Assembly on December 11th, 1972, and is prescribed in Article 1, Paragraph 2 of the Act on Special Measures Incidental to Enforcement of the "Agreement between the United Nations and Japan regarding the headquarters of the United Nations University" (Act No. 72 of 1976)
  - (Hereinafter referred to as the "United Nations university"), and has been conferred a degree equivalent to a master's degree or is expected to acquire one by March 31, 2025
- (6) have taken an educational course at a school in a foreign country, an educational institution designated in (3) above, or the United Nations University, and have passed or are expected to pass by March 31, 2025 the examination and screening prescribed in Article 16-2 of the Standards for the Establishment of Graduate Schools, and who are recognized by the Graduate School as having academic ability equivalent or superior to that of a master's degree holder.
- (1) Those who have graduated from a university, etc. and have been engaged in research at a university, research institute, etc. for two years or more, and who are recognized by the graduate school as having academic ability equivalent to a person with a master's degree.
  - (2) A person who has completed 16 years of school education in a foreign country or 16 years of correspondence courses provided by a foreign school in Japan, and who has been engaged in research at a university or research institute for 2 years or more, and who is recognized by

- the graduate school as having academic ability equivalent or superior to a person with a master's degree based on the results of said research.
- (8) be recognized by the Graduate School as having academic ability equivalent or superior to a master's or professional degree, and who will reach 24 years of age by March 31, 2025.

The Graduate School of Education has established a system of "Special Exception for Educational Programs Based on Article 14 of the Standards for the Establishment of Graduate Schools" to facilitate graduate school study for those who need it, such as those who are currently employed.

This system allows students to study flexibly under the permission and guidance of their supervisor based on the curriculum stipulated in the graduate school regulations.

If you wish to apply for the system, please submit "Application for Special Exceptions to the Educational Programs Based on Article 14 of the Standards for the Establishment of Graduate Schools" at the time of application.

Reference: Standards for the Establishment of Graduate Schools (1974, Education Ministry Ordinance No. 28) [Extract].

Article 14 In a graduate course, education may be provided by appropriate methods such as holding classes or research guidance at night or at other specified times or periods, when deemed necessary for special educational purposes.

### (3) Payment of application fee

The entrance examination fee is 30,000 yen.

Please fill out the bank transfer request form attached to this application guideline and make the transfer at a financial institution (bank, credit union, credit cooperative, agricultural cooperative, or fishery cooperative) that allows money transfers at the teller window. Applicants are required to pay the bank transfer fees.

Please note that financial institutions are closed on Saturdays, Sundays, and national holidays. In addition, transfers from Japan Post Bank, post offices, ATMs (Automated Teller Machines), cell phones, and personal computers will not be accepted.

### [Refund of application fee]

In principle, the application fee is not refundable after the application documents are received. However, applicants may apply for a refund, if you cancel your application after transferring the application fee. Please contact the university by Friday, September 27, 2024, for the first term admission and by Friday, March 7, 2025, for the second term admission. # 14. Privacy Policy

The Graduate School allows students to enroll in the program for a maximum of six years.

If approved at the time of admission, the total amount of tuition paid for the normal term of study (3 years) will be divided equally each semester during the approved extended period of study.

Those who are eligible to apply for the long-term enrollment are those who fall under any of the following conditions and have difficulty in completing their studies within the standard term of study.

(1) Those who are employed

- (2) Those engaged in housework, childcare, nursing care, etc.
- (3) Persons with physical disabilities, intellectual disabilities, mental disabilities (including developmental disabilities)


